## **JET 2021**

### **Information Bulletin**

**Introduction:**

Candidates desirous of seeking admission to Satyajit Ray Film & Television Institute, Kolkata (SRFTI) and Film & Television Institute of India, Pune (FTII), leading educational institutions in the art & craft of film making and television production, need to go through a multi-stage selection process. The First Stage in this selection process is an All India Level written examination called as the Joint Entrance Test, 2021 (JET 2021), which is a written test of three hours' duration consisting of objective type and subjective questions and will be conducted in 27 cities across India. Based on the JET 2021 score of the candidates, SRFTI and FTII will shortlist the candidates for the Second Stage of the selection process and thereafter, on successful accomplishment of all the requisites, finally admit students in their full time regular programmes for the academic year 2021.

**JET 2021** is a pre-requisite for admission to any of the courses of SRFTI and FTII.

### JET 2021 MINIMUM EDUCATIONAL QUALIFICATION

The minimum educational qualification required to be eligible for application for all courses except Art Direction & Production Design is **Bachelor's Degree or equivalent in any discipline. For Art Direction & Production Design, the eligibility is as under:**

Name of the Specializations	Minimum Educational Qualification
Art Direction & Production Design	Bachelor's degree in applied arts, architecture, painting, sculpture, interior design or related fields in fine arts or equivalent.

### Courses under the EDM (SRFTI) /TV (FTII) Group

The minimum educational qualification required to be eligible for application for all courses is **Bachelor's Degree or equivalent in any discipline.**

Candidates appearing for the final year of Bachelor's degree, and awaiting results, can also apply for JET 2021. However, it may be noted that such candidates, if selected, are allowed to join the course, only if they submit a passing certificate from the Controller of Examinations/ Principal/ Registrar or any other equivalent competent authority of the University/ Institution, stating that the candidate has appeared for his/ her graduation examination in the academic year 2021-22 and based on this examination, he/she is a graduate.

## RESERVATIONS

In terms of the legal framework, 15% of the seats are reserved for Scheduled Caste (SC), 7.5% for Scheduled Tribe (ST), 27% for Other Backward Classes candidates belonging to the “Non-Creamy” layer (OBC-NCL), and 10% for Economically Weaker Section (EWS) as Gen.\_EWS. Further, 5% of total seats are reserved on horizontal basis for Persons with benchmark Disabilities.

As defined in The Rights of Persons with Disabilities Act, 2016 (RPwD Act 2016), “person with benchmark disability” means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. “Specified Disability” means the disabilities as specified in the Schedule of the RPwD Act 2016.

The candidates belonging to the PwD categories are further required to refer to the prospectuses of participating institutes and note the eligibility requirements carefully before applying.

It should be noted that while it is the endeavour of both institutions that the candidates belonging to SC/ ST/ PwD/ OBC – NCL/ Gen.\_EWS categories join the programme in proportions mandated by the law, they have to meet the minimum eligibility criteria and a certain minimum level of performance to be considered for the admission process. The candidates should read the updated description of selection process followed by each institute in their respective prospectuses and websites.

**NOTE:** *No change in the category will be entertained after JET registration; hence, the candidates are required to give due care while registering. SC, ST, OBC-NCL, Gen.\_EWS and PwD candidates must upload a copy of their SC / ST/ OBC – NCL/ Gen.\_EWS/ PwD certificates in the prescribed form at the time of registration. Candidates claiming OBC-NCL status may please note that the OBC certificate, including non – creamy layer status should have been issued on a date within one year before the closing date of receiving application. Candidates claiming PwD status should submit latest certificate in the prescribed form which should have been issued on a date within six months before the closing date of receiving application. Candidates claiming EWS category/ status should submit latest certificate in prescribed form which should have been issued on a date within one year before the closing date of receiving application. Certificates not fulfilling these conditions will be held invalid, and therefore unacceptable.*

*Instances of any incorrect information or violation of process detected at any stage of the selection will lead to immediate disqualification of the candidate from the selection process and he/ she will not be allowed to appear for JET in future. If such instances go undetected during the current selection process but are detected in subsequent years, such disqualification will take place with immediate effect.*

## PAYMENT OF JET REGISTRATION FEE

(The JET Registration Fee shall be accepted through online modes of payment i.e. Debit Card/ Credit Card only)

Please note that for the courses which are offered by both institutes, a candidate needs to pay registration fee only once, and he/she will be considered for admission to both Institutes.

**A candidate can apply maximum one course from Group A, one course from Group B, and one course from Group C.** Fee paid will be non – refundable, non – transferable, non – adjustable etc. under any circumstances. Bank charges for online transaction will have to be borne by the applicant.

## REGISTRATION FOR JET 2021

The registration window opens at 4 pm on **03.11.2021** and will close at **11:00 p.m. on 02.12.2021**. The details will be available in the registration guide on the JET website.

At the time of registration, the candidates have to select any three test cities as per their preference from the drop down menu. After the last date of registration, candidates will be allotted one among the 3 preferred cities. In the rare case that a candidate is not allotted any of the preferred cities, he / she will be allotted a nearby city. The candidates can download the admit cards from **08.12.2021 to 17.12.2021**.

**NOTE:** *Admit cards will not be sent by post or by email*

## TEST CENTRES

JET 2021 will be conducted in centres spread across 27 cities. Details about the test centres in these test cities will be available on this website from **08.12.2021** and the name & address of the test centre will be indicated in the Admit Card.

The institutes reserve the right to change or cancel any test centre/ city and/or change the test time and date at its own discretion.

## ENTRANCE AND PAPER CHECKING

The written test will be of 3 hours for 100 marks as per details below.

Paper I: (Time provision 90 min.)

Part A: Multiple Choice Questions (Single Answer type) 20 marks [on OMR sheet]  
Part B: Multiple Select Answer type Questions (MSQs) 30 marks [on OMR sheet]

Paper II: (Time provision 90 min.)  
Descriptive Answer type Questions 50 marks.

Part I & II of all the eligible appeared candidates will be evaluated. Further, based on the evaluation of Part I & II, Part III of only selected nos. of top scoring candidates (based on the respective category) will be evaluated using the following ratio against each seat:

1. For all the courses except FTII's Screen Acting course:

- i) Unreserved, OBC\_NCL and Gen\_EWS: 1:15 (One seat:15 answer-sheets)
- ii) SC, ST, Gen\_PwD, OBC\_NCL\_PwD and Gen\_EWS\_PwD: 1:25 (One seat:25 answer-sheets)
- iii) SC\_PwD and ST\_PwD: 1:35 (One seat:35 answer-sheets)

2. For FTII's Screen Acting Course\*

- i) Unreserved, OBC\_NCL and Gen\_EWS: 1:45 (One seat:45 answer-sheets)
- ii) SC, ST, Gen\_PwD, OBC\_NCL\_PwD and Gen\_EWS\_PwD: 1:75 (One seat:75 answer-sheets)
- iii) SC\_PwD and ST\_PwD: 1:105 (One seat:105 answer-sheets)

## **JET 2021 SCORE**

Candidates' JET 2021 score card will be made accessible on the JET website. JET 2021 score is valid only till September 30, 2022 and will accordingly be accessible on the website. Thereafter, no queries (online/offline) related to issuance of JET 2021 score cards will be entertained.

## **ADMISSION PROCESS**

Please note that each institute i.e. FTII and SRFTI is independent to mandate their own eligibility criteria and follow different evaluation procedure, post the JET 2021 selection process. Performance in JET 2021 examination is an important component for consideration in the selection process.

On the basis of performance in JET-2021, the list of candidates short-listed for the next level of selection will be made available on the website of the respective institutes. Each institute will send emails to the short-listed candidates directly. The criteria for short listing may vary for different courses. Please visit the websites of the Institutes and read the prospectuses carefully for more information.

**Medical Test:**

Candidates who are short-listed on the basis of JET 2021 will be required to undergo Medical Test as per the selection criteria of both institutes. Procedure of the Medical Test shall be communicated to the shortlisted candidates by the respective institutes.

Candidature of a short-listed candidate can be cancelled on the basis of the outcome of Medical test. Decision of respective institutes in this regard would be final & binding on all concerned.

For more information, candidates must refer to the respective websites and prospectus of FTII and SRFTI respectively.

**IMPORTANT:**

1. Both FTII and SRFTI are free to verify eligibility of candidates at any stage of the selection process and after admission.
2. Candidates are required to read the prospectus of institutes for eligibility and the detailed admission process.
3. Candidates should note that the mere fulfilment of minimum eligibility criteria will not ensure consideration for short listing by either of the Institutes.
4. All important information on JET 2021 including any subsequent Corrigendum / Changes / Updates and shall be made available on the website only.
5. Candidates must declare and maintain a valid and unique email account and a mobile phone number throughout the selection process and should simultaneously track the JET website and website of participating institutes for updates. The participating institutes will not be responsible for any non-receipt of intimation to a candidate.
6. The JET 2021 scores are not allowed to be used by any other institute except the participating institutes i.e., SRFTI and FTII.
7. Any dispute concerning JET 2021 would be subject to jurisdiction of the competent courts within the territorial jurisdiction of city of Kolkata only.
